Eligibility: The 'Big Fresno Fair Ticket Giveaway' is open only to those that 'Like' or 'Follow' 'Amtrak San Joaquins Facebook Page,' 'Follow' 'Amtrak San Joaquins Instagram Profile' or 'follow' 'Amtrak San Joaquins Twitter Profile.' The 'Big Fresno Fair Ticket Giveaway' is only open to legal residents of the state of California and is void where prohibited by law. Residents of Fresno, California are not eligible to participate. Employees of San Joaquin Joint Powers Authority, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the 'Big Fresno Fair Ticket Giveaway'. Agreement to Rules: By participating, the 'Big Fresno Fair Ticket Giveaway' ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of the San Joaquin Joint Powers Authority as final and binding as it relates to the content of the 'Big Fresno Fair Ticket Giveaway'.

3. 'Big Fresno Fair Ticket Giveaway' Period: Entries will be accepted at Amtrak San Joaquins Facebook Page, Instagram Profile and Twitter Profile starting on October 6, 2017 and ending October 8, 2017. All Amtrak San Joaquins Facebook Page, Instagram Profile and Twitter Profile entries must be received by 11:59PST October 8, 2017.

4. How to Enter: The 'Big Fresno Fair Ticket Giveaway' must be entered by commenting or replying to the Big Fresno Fair Contest Announcement Post on Facebook, Instagram or Twitter. Participants must also like/follow/subscribe to at least one of Amtrak San Joaquins' social media channels: Facebook, Instagram, Twitter or YouTube. The entry must fulfill all 'Big Fresno Fair Ticket Giveaway' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin

Joint Powers Authority. You may enter only once. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of the San Joaquin Joint Powers Authority.

No cash or other prize substitution shall be permitted. The prize is nontransferable. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for the San Joaquin Joint Powers Authority to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of the San Joaquin Joint Powers Authority. Winner will be notified based on the social media channel he or she commented or replied to respectively. For Facebook, Winner will be notified by Facebook Direct Messenger within one (1) day following selection of Winner. For Instagram, Winner will be notified by Instagram Direct Message within one (1) day following selection of Winner. For Twitter, Winner will be notified by Twitter Direct Message within one (1) day following selection of Winner. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk email or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 1 day from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority. The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 'Big Fresno Fair Ticket Giveaway' or violates these Terms & Conditions. Limitation of Liability: By entering, You agree to release and hold harmless the San Joaquin Joint Powers Authority and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the 'Big Fresno Fair Ticket Giveaway' and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v)

Further, in any such dispute, under no circumstances shall participant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this 'Big Fresno Fair Ticket Giveaway').
