The 'California Musical Theatre Ticket Giveaway' is only open to legal residents of the state of California and is void where prohibited by law. Residents of Sacramento, California are not eligible to participate. Employees of San Joaquin Joint Powers Authority, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the 'California Musical Theatre Ticket Giveaway'. The 'California Musical Theatre Ticket Giveaway' is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

3. 'California Musical Theatre Ticket Giveaway' Period: Entries will be accepted at Amtrak San Joaquins Facebook Page starting on November 27, 2017 and ending December 1, 2017. All Amtrak San Joaquins Facebook Page entries must be received by 11:59PST December 1, 2017.

4. How to Enter: The 'California Musical Theatre Ticket Giveaway' must be entered by commenting or replying to the California Musical Theatre Contest Announcement Post on Facebook. Participants must also like/follow/ subscribe to at least one of Amtrak San Joaquins' social media channels: Facebook, Instagram, Twitter or YouTube. The entry must fulfill all 'California Musical Theatre Ticket Giveaway' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin Joint Powers Authority. You may enter only once. If You use fraudulent methods or otherwise attempt to circumvent the rules, your

submission may be removed from eligibility at the sole discretion of the San Joaquin Joint Powers Authority.

5. No cash or other prize substitution shall be permitted. The prize is nontransferable. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for the San Joaquin Joint Powers Authority to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of the San Joaquin Joint Powers Authority. Winner will be notified based on the social media channel he or she commented or replied to respectively. For Facebook, Winner will be notified by Facebook Direct Messenger within one (1) day following selection of Winner. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk email or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 1 day from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority. The San Joaquin Joint Powers Authority reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the 'California Musical Theatre Ticket Giveaway' or violates these Terms & Conditions.
