4. How to Enter: The 'Lodi Wine & Chocolate Ticket Giveaway' must be entered by commenting on the 'Lodi Wine & Chocolate Ticket Giveaway' Contest Announcement Post on Facebook. Participants must also like/follow/ subscribe to at least one of Amtrak San Joaquins' social media channels: Facebook, Instagram, Twitter or YouTube. The entry must fulfill all 'Lodi Wine & Chocolate Ticket Giveaway' requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the San Joaquin Joint Powers Authority. You may enter only once. The San Joaquin Joint Powers Authority shall have no liability for Winner's failure to receive notices due to spam, junk email or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. In such case, the San Joaquin Joint Powers Authority may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the San Joaquin Joint Powers Authority.
